Subject: Ekayanaa Scholarship Programme for Class XI of 2023-24

**Dear Parents** 

Namaste

"We are delighted to announce a scheme whereby handsome scholarships and relaxation in attendance" are given to the deserving Ekayanites for their studies in classes XI & XII, as per stipulated norms. The scholarship is designed to recognize and support exceptional students who are committed to their studies. It also aims to encourage our students and counter the unhealthy and unsafe option of joining dummy schools, generally considered by Science students.

By opting this healthy option, you can avoid many risks your ward is subjected to when he/she joins dummy schools.

The entire scheme is as follows:

### **SCHOLARSHIPS:**

The school will grant scholarships to students based on their performance in **Class 10<sup>th</sup> Board Examination.** 

The scholarship is awarded in two categories:

### Category A:

- Students who score 90% and above will pay only ₹ 50,000/- (₹ Fifty Thousand only) per annum, all inclusive.
- Effective scholarship amount comes to ₹ 62,000/- per year.

## Category B:

- Students who score minimum 80% but less than 90% will pay only ₹ 60,000/- (₹ Sixty Thousand only) per annum, all inclusive.
- Effective scholarship amount comes to ₹ 52,000/- per year.

The scholarship will be for both Classes XI and XII, subject to consistency in performance of the student in Class XI.

### RELAXATION POLICY FOR SCIENCE STUDENTS ONLY

Relaxation in Attendance will be granted as per the student's justifiable need and after discussion with the Principal.

### **Conditions for Relaxation:**

- 1. The Practical and project works which are mandatory according to CBSE rules for being eligible for final exams, will have to be done by the student on time.
- 2. Practical file and project file have to be written by the student in his / her own handwriting and submitted for correction within the stipulated time as specified by the CBSE.
- 3. The student may attend classes of optional subject/s and English as per his/her need and mutual understanding.
- 4. In Class XI students who are granted relaxation will be required to appear for the Half Yearly and Final Examination (both theory and practical) based on the CBSE Syllabus.
- 5. It is mandatory for students to update the school of their result in the Tests / Examination at their respective coaching centers.
- 6. If the student's performance in the internal exams of the school / coaching center is not satisfactory / justifiable, the extent of relaxation in attendance will be reviewed.

We encourage all eligible students to apply for this exciting opportunity to further their education and achieve their goals. We are committed to supporting the success of our students and believe that this scholarship will provide a valuable opportunity for students to excel in their academic pursuits.
